

2018 School Fees and Levies

(10% discount for 3, 20% for 4, 30% for 5 children in family in Catholic Schools)

Kinder fees and levies: 1 child = \$1,455 per annum
(please note that the \$200 enrolment deposit will be credited to this charge)

Prep to 6 Fees and General Levies: 1 child = \$1,525 per annum
 2 children = \$3,050 per annum
 3 children = \$4,117.50 per annum
 4 children = \$4,880 per annum

Additional Levies not generic to every school: \$85 per annum per child (Prep to 6)

Capital Levy: (CEO Building Maintenance Levy) \$230 per annum per family

You may choose one of the following payment options:

Option 1: Payment in full. A 5% early payment discount from tuition fees and general levies will be offered with this option. To be eligible, full payment will need to be paid on or before **Thursday 31 March 2018.**

Option 2: 10 equal Instalments via a Credit Card (Visa/Mastercard) **OR** from your Bank Account via Catholic Development Fund. These instalments will be debited on the 25th of the month to begin 25 February 2018 and conclude on the 25 November 2018.

Option 3: Centrepay fortnightly arrangement (contact school office to set up).

Option 4: Continue with my current weekly/fortnightly/monthly arrangement via Direct Debit or Credit Card. I understand payments will be increased to an amount required to cover next year's fees and levies as from the first payment in January 2018, unless arrangements have been made with the school for a reduced payment plan.

Our fees and levies have increased by a total of 2.56% to align with Catholic Education Office requirements. When the School Board agreed to the increase it was with the understanding that no child would be declined enrolment or lose enrolment based on financial reasons or constraints. Please make an appointment with Mrs Wootton to discuss fee options should the need arise.

Reduced payment plans should be reviewed each year, and if you are already on such a plan, you are requested to complete a new Application for Fees Assistance and ensure that a direct debit form is in place for 2018.

Invoice terms

Invoices will be issued to you at the commencement of the new school year. Full payment will be due by 31st March 2018, unless other arrangements are made using the attached payment arrangement form.

Please note that any payment arrangement entered into is purely administrative. In the event of default on payment arrangements, the total amount outstanding will become immediately due and the school reserves its right to take steps to recover it in full.

As families with 3 or more students enrolled in Catholic schools are eligible for discounts, monthly fees can vary from family to family. Please contact the school office if you need assistance to work out what your monthly commitment will be.
